### Instructions for use:

Local use only. A small pellet of Alvocure should be applied aseptically to cover the socket after verification and cleaning the socket. Do not suture. The dispensed material shall not be placed back in the container and the dose once applied or used shall not be reused.

#### Warnings:

Avoid prolonged or repeated contact with skin (allergic contact dermatitis), and eyes. Avoid prolonged inhalation. Do not take internally. Contact with the skin may cause irritation, burns of hypersensitivity. If contact with skin occurs immediately wipe off thoroughly with cotton soaked in alcohol and then wash well with soap and water. If skin rash and sensitization or other allergic reaction occurs, discontinue the use and seek medical attention. If the product comes into contact with the eyes, rinse thoroughly with fresh water and consult a physician.
