Composition:

Powder Contains: Zinc Oxide, Barium Sulphate, Accelerators, Preservative.

Intended Purpose / Intended Use: It is used as permanent root canal filling material. Indications for Use: Root canal filling and sealing in association with a gutta perchapoint.

Instructions for Use: Mix carefully for approximately 45-60 seconds, one scoop of powder and 3 - 5 drops of liquid to obtain smooth and homogenous mix, which can easily be introduced into the canal. The dispensed material shall not be placed back in container and the dose once applied and used shall not be reused.

Warnings: Avoid prolonged or repeated contact with skin (allergic contact dermatitis), and eyes. Avoid prolonged inhalation. Do not take internally.
