Product Description : Zical Ultra Root Canal Sealer is a zinc oxide-eugenol resin based sealer in powderliquid form for permanent filling of root canals.

Composition :

Powder: Zinc oxide, Iodoform, Hydrogenated Rosin, Barium Sulphate, Zinc Acetate, Bismuth subcarbonate

Liquid : Eugenol, Olive Oil

Intended use: It is used for permanent filling of dental root canals.

Indications for use: ZICAL ULTRA is used for permanent obturation of the root canal space with the aid of obturating points.

Instructions for use: The root canal should be thoroughly dry before filling. Over filling root canals should be avoided. Both glass slabs and spatula should be clean and thoroughly dry for to use for mixing cement. Place 1 scoop of powder and 4-5 drops of liquid on the glass slab. Spatulate small portions of the powder into liquid until entire powder is homogeneously mixed. Gradually add more portions of powder to the mix spatulating thoroughly for 2:00-2:30 (min :sec) until a very smooth creamy paste is obtained. Working time is 30 minutes. Introduce the paste into the prepared root canal with a suitable instrument. Insert the Gutta Percha point and seal the coronal end. Net setting time is 45-60 minutes from start of the mix. The dispensed material shall not be placed back in container and the dose once applied and used shall not be reused.

Warnings: Avoid prolonged or repeated contact with skin (allergic contact dermatitis), and eyes. Avoid prolonged inhalation. Do not take internally. Contact with the skin may cause irritation and hypersensitivity. If contact with skin occurs immediately wipe off thoroughly with cotton and alcohol and then wash well with soap and water. If skin rash and sensitization or other allergic reaction occurs discontinue the use and seek medical attention. If the product comes into contact with the eyes, rinse thoroughly with fresh water and consult a physician. It should not be used with patients who have a history of severe allergic reaction to any of the components.

Store at temperature between 10°C(50 °F) to 24°C(75 °F). Close the cap carefully after use. Keep away from moisture. Shelf life not affected after opening if stored in a cool dry place.
